Subject: To Obtain Choice of Stations for Modification of Place of Posting from those Newly Recruited Teachers who have been selected on direct recruitment in 2017 and onward, posted on Zonal basis & their Spouses are working in KVS and other Central/ State Government Departments/ Central PSUs – reg.

Madam/Sir,

With regard to the subject cited above this is to inform that KVS has appointed teachers selected through direct recruitment in 2017 and onward and posted in the 6 zones by adopting the criteria of Merit-Cum-Choice as per the availability of vacancies earmarked category wise for the direct recruitment in the each zone.

Due to the adoption of this uniform criteria for allotment of zones to all newly recruited teachers by the KVS, some teachers whose spouses are working in KVS and other Central/State Government Departments/ Central PSUs have been posted far away from the place of posting of their spouses, consequently, KVS has received many representations from such employees for the change of their place of posting on account of posting of their spouses.

The matter was discussed in the 109th Meeting of Board of Governors of KVS held on 06.03.2018. The BOG has relaxed the criteria of Merit-Cum-Choice in the cases of such employees adopted by the KVS for allotment of zones and allowed to consider their request for modification of place of posting as far as possible.

In compliance with the said decision of the BOG, the KVS has decided to obtain choices of places from such employees to modify their place of posting as far as possible. You are, therefore, requested to issue the suitable directions to the Principals working under your administrative control to obtain choice for places for modification of present place of posting from such teachers in the prescribed proforma (attached). Teachers covered under this provision will give at least choice of 10 stations including place of posting of his/her spouse and nearby. All such choices submitted by the teachers in the Vidyalaya shall be forwarded by the Principals to the Regional Offices for further compilation by 18th April, 2018 and the same will be complied at Regional Office l and sent to KVS HQ in the same proforma as used at the Vidyalaya (excel sheet only). The data should be sent to e-mail id kwse23@gmail.com before 20.04.2018 to KVS HQ.

Format of application (for obtaining choices) to be submitted by teachers to the Principal is also enclosed herewith for their ready reference. The Principals should be directed to obtain Service and posting Certificate of spouse from all such employees which shows his/her full particulars and place of posting clearly. This certificate should be issued by the controlling officer of the employee concerned. The Principal, on the basis of this certificate will forward the choices submitted by the employees to the Regional Offices by 18.04.2018. Copy of applications and certificate of working of spouse submitted by the teachers to the Principal SHOULD NOT be sent to KVS HQ and Regional Offices. The same should be retained in the Vidyalayas for further and future reference.

It is reiterated that this relaxation has only been given to those employees who have been selected on direct recruitment in 2017 and onward and posted in the Zones on Merit-Cum-Choice and their spouses are working in KVS and other Central/ State Government Departments/ Central PSUs. Other employees who are not covered under this provision need not to submit their options.

This may be treated as MOST URGENT.
