Subject: Promotion of Students of Classes IX & XI for session 2019-20 due to outbreak of COVID-19 regd-

Ref.: CBSE Press Release dated 01.04.2020.

Madam/Sir,

As per the CBSE press release dated 01.04.2020 the Guidelines to be followed for promotion for Class 9 and 11 are as follows:-

"....It has come to the notice that though several schools affiliated to CBSE have completed their examination, evaluation and promotion process for students who were studying in grades 9 and 11 in the 2019-2020 academic session, there are several schools that have not been able to do so. This includes among others, KendriyaVidyalays, NavodayaVidyalayas, state /UT government schools, private schools, schools located in India and abroad etc. All such schools are advised to promote students of grades 9 and 11 to the next grades on the basis of all the school based assessments including project work, periodic tests, term exams etc conducted so far.For any Child who is unable to clear this internal process (in any number of subjects), the school may utilize this period for providing remedial interventions and school may give opportunity of appearing in school based test/s, online or offline. The promotion of such children may be decided on the basis of such tests...."

In the light of the above I am to convey the decision of the Competent Authority of KVS that the result of classes IX & XI for the session 2019-20 may be prepared in the following manner

- 1. Most of the regions have completed session ending exam for maximum number of subjects for classes 9 and 11. Hence for those subjects the calculation of weight-age criteria remains the same as existing one.
- 2. For the subjects where exam could not be conducted due to lockdown or outbreak of Coronavirus the following method for weightage may be considered:

Calculation of Weightage in the subjects for which Examination could not be conducted as under: (a) Class IX:

Clarification: For Class IX:

- (i) Two best Periodic Test out of three may be taken separately now and not to be included in Internal Assessment. The weightage for PTs is 40 Marks each. Hence total of 2 PTs is 80 Marks; this can be considered as pen paper test in lieu of Session Ending exam.
- (ii) New weightage for Multiple Assignments is 10 Marks instead of 5 Marks which were taken previously.
- (iii) Portfolio and Subject Enrichment weight-age remains the same i.e. 5 Marks each.
- (IV) Now, the total will be 100 Marks, i.e. 80 Marks of Periodic Test and 20 Marks of internal assessment.

(b) For Class XI

Clarification for Class XI:

- (i) The weight-age for Half Yearly is 40/35 marks. (50% of Max Marks for which the exam was conducted)
- (ii) Then the total of UT1+UT2+HY= 10 + 10+40/35 (60/55 Marks)
- (iii) To keep the weightage of these subject (where session ending exam is not conducted) similar to other subjects (whose session Ending exam is already conducted) 60/55 Marks are converted to 80/70 marks.

- (iv) Project/Practical/ Internal Assessment is already conducted before the theory exams hence Marks allotted to project/practical/ Internal Assessment i.e.20/30 marks to be considered instead of weightage 10/15 marks.
- (v) For promotion to next higher class the student has to secure 33% Marks in aggregate including (Theory and Practical Exams/project /Internal assessment taken together) for the session 2019-20 only as per CBSE press release dated 01/04/2020.
- (vi) For Maths subject also the above criteria will be same.
- (vii) Rest of the instructions remains the same.

Norms for promotion:-

For Class IX:- The students who could not secure 33% in any of the subjects as per the above criteria are to be given an opportunity of retest in those subjects (**Any number of subjects**).In order to get promotion to the next class, students will be required to secure minimum 33% in all the subjects of retest.

For Class XI:- Students, who could not secure 33% Marks in any of the subject(s), may appear in the retest (Any number of subjects).

- (i) The retest in the form of online/ offline test for the above mentioned students will be conducted after the school reopens. The question paper for the retest will be as per the standard blue print already circulated.
- (ii) A Minimum of 5 days notice will be given to all the students before starting the supplementary exam/Retest.
- (iii) No student should be detained on the basis of above criteria including those Regions where all the exams have already been conducted and opportunity of retest will be given to all. This would ensure parity and uniformity across all the Regions of KVS.
- (iv) In order to promote a student to the next higher class, he/she has to pass in all the subjects of retest with 33% marks.(Theory and practical taken together) failing which He/ She will be detained in the same class.

Important note:

- 1. All care should be taken to ensure accuracy in preparation of results by carrying out checking also before its declaration through digital mode however, as an extra precaution due to closure of schools on account of lockdown, the answer scripts/ award lists/ postings in result register of all those students who are placed in compartmental exams, shall be rechecked and re-totaled once again within two working days from re-opening of the schools and amendments in results, if any, shall be done immediately under intimation to the child/ parent.
- 2. The existing provisions of providing additional points/ marks/ weightage to the students in pass/ promotion for achievements in various fields shall be extended as per existing policy.

- 3. The other criteria for Result preparation of Class IX & XI will remain the same.
- 4. The above relaxation are given to the students of classes IX & XI for session 2019-20 only in special circumstances in respect of crisis of Coronavirus or COVID-19.
- 5. The results of Classes IX & XI will be communicated to the parents/guardians through email/WhatsApp/SMS
- 6. As far as possible the results of Classes IX & XI may be declared by 15.04.2020.
- 7. The teachers/students may be advised to start their study through Digital Mode .

You are, therefore requested to give necessary directions to all the Kendriya Vidyalayas under your jurisdiction for necessary action.

This issues with the approval of Competent Authority of KVS.
